Hydrant Meter Policy

Hardin County Water District No. 2 (HCWD#2) will provide, upon request of consumer (USER), a temporary metered connection on a fire hydrant for consumer use. Prior to meter installation or use, the user must complete a Hydrant Meter User Agreement and an Application for Service as a Commercial user in person at HCWD#2 Customer Service Center. Once the user has established a Commercial account and has provided a \$2,000.00 deposit, HCWD#2 will install a 3 inch meter with backflow device to a fire hydrant within HCWD#2 territory in a location agreed upon by HCWD#2 and the user. HCWD#2 will have the final say as to which fire hydrant the meter will be connected to. The meter shall be connected, disconnected, or relocated by HCWD#2 personnel only. The user will be billed on a monthly basis or when service is terminated according the rates established for a 3 inch meter as set forth by HCWD#2 tariffs. Due to freezing temperatures, hydrant meters may not be available through winter months.

FIRE HYDRANT METER USER AGREEMENT

This agreement entered into between _____ the user, whose address is _____, hereinafter called "USER" and Hardin County Water District #2, 360 Ring Road, Elizabethtown, KY, hereinafter called "SUPPLIER".

Whereas, the USER desires to purchase water through a metered fire hydrant connection from the SUPPLIER, the USER hereby enters into this fire hydrant user agreement with the SUPPLIER.

Now therefore, in consideration of the mutual covenants, promises, and agreements herein contained, it is hereby understood and agreed by the parties hereto as follows:

The SUPPLIER shall install a 3 inch fire hydrant meter for such quantity of water as the USER may desire from the metered hydrant connection.

The USER agrees to comply with and be bound by the Rules and Regulations of the SUPPLIER, now in force or as hereafter duly and legally supplemented, amended, or changed.

The USER agrees to pay to the SUPPLIER a deposit fee of \$2,000.00, refundable upon termination of service and payment of all monies owed to SUPPLIER and after the return of hydrant meter.

The USER agrees to pay for all water used at the 3" meter rate and agrees to the imposition of such penalties for noncompliance as are now set out in the SUPPLIER'S Rules and Regulations, or which have been or hereafter be adopted and imposed by the SUPPLIER.

The SUPPLIER agrees to locate the meter on a hydrant within the SUPPLIER's territory at a location mutually agreed upon by the SUPPLIER and USER. The SUPPLIER shall have the final say as to which hydrant the meter will be connected to.

The USER agrees to pay a connection fee of \$25 for the installation of the hydrant meter and a \$25 disconnection fee for the removal of the hydrant.
